- International
- Evaluation
- Humorous
- ▶ Table Topics[™]

- Tall Tales
- Video (for members of undistricted clubs and for provisional districts)

*undistricted clubs = provisional clubs, on-line clubs

District Requirements



- Districts must hold the International Speech Contest every year.
- Districts are allowed to hold up to three additional contests per year.




Speech Contest Progression

 - Oct 15, 2023 December 10, 2023
- Area Contests
 - December 11, 2023 February 10, 2024
- Division Contests
 - February 11, 2024 March 31, 2024

Speech Contest Season



- District Contest
 - Announced by District (anticipated 3rd week of April)

Speech Contest Logistics



- Club contests in person or on-line (club choice)
- Area, Division, and District In Person

Eligibility for All Contests



 There is a list of positions held throughout the district which are ineligible for competition (Page 6-7 of the rule book)

Eligibility for Evaluation Contestants TOASTMASTERS TOAS

- Paid Member in the area, division, and district you are competing
- Club must be in good standing
- New, dual, or reinstated member must have dues and membership application on file with World Headquarters
- Maintain eligibility at all levels of any contest

Eligibility - International Contestants

- Paid Member in the area, division, and district you are competing
- Club must be in good standing
- New, dual, or reinstated member must have dues and membership application on file with World Headquarters
- Maintain eligibility at all levels of any contest


Eligibility - International Contestants

Content Eligibility



- Speech Content Must Be Original
- Twenty-five percent or less of the speech may be devoted to quoted, paraphrased, or referenced content must be so identified during the speech presentation
- Contestants must not reference another contestant, or a speech presented by another contestant, from the platform at the same contest in which they are competing



Eligible Content

International Speech Contest: 5-7 minutes, any topic of the contestant's choosing.

Content Eligibility



- Contestants must complete Item 1183
 certifying in writing to the Chief Judge the
 content of their speech is substantially original
- All contestants will speak from the same platform Area designated by the contest chair

Contest Chair

- Plan the Contest
- Select Date / Time / Location
- Create the Agenda
- Download Certificates
- Order Trophies
- Verify Speaker Eligibility
- Can serve as Contest Toastmaster if one is not selected



Contest Toastmaster

- Runs the contest
- Brief the Contestants
- Works with Contest Chair to setup and run speech contest
- Reads the script and MCs the Contest



Chief Judge

- Appoints & Briefs Voting Judges, Ballot Counters, Timers, and Secret Tie Breaking Judge
- Provides Counters' Tally Sheet and Timer's Sheet
- Conduct Judges and Functionary Briefing
- Oversees Ballot Counting



Judges Eligibility

- Club Contest paid member
- Club in good standing

Eligibility - Judges



- Club Contest a paid member
- Area, Division, or District Contest
 - Paid member for 6 months
 - Completed 6 speech projects in the Competent Communication (prior to the rollout of Pathways), or earned certifications of completion in Levels 1 and 2 of any path in the Toastmasters Pathways learning experience
 - Be physically present at the contest for which you are serving

Eligibility - Judges



- Area, Division, or District Contest
 - Same club prohibition at division and above



Timer's Role

- One timer uses stopwatch to time speech for the record
- One timer controls signaling cards for the speaker



Ballot Counter's Role

- Collects ballots from voting judges
- Leaves the contest room with Chief Judge to tally ballots
- Must interrupt the announcement of contest winners if announced incorrectly.



Sergeant at Arms Role

- Escort Speakers from waiting area to speaking area
- Supervises contestants not speaking in the waiting area
- Secures doors to the contest venue

Speech Contest Rules to Note



- Contestants may only be nominated at club level
- Area, Division, and District contests must be held
- Traditional eligibility requirements (previous program) – apply towards Judge's eligibility only

Speech Contest Rules to Note



- Contests with one contestant must be held at contests beyond the club level. The contestant must be disqualified if they do not meet the timing, originality and eligibility requirements
- Protests must be lodged prior to the contest being adjourned.


